

Contract terms, The Deadlands

payable to Contributors within thirty days of publication by the Publisher of the Work, Contributor hereby grants to *The Deadlands* the following Primary Rights and Ancillary Rights in and to the Work as a whole.

Online Rights, which shall mean the right to transmit, broadcast, distribute, display, adapt (only as necessary for purposes of technical implementation as contemplated herein), digitally store, permit access to and reproduce the Work in whole or part, on the Internet and/or as part of Publisher's websites and online or related services.

Contributor further acknowledges and agrees that, until four months have elapsed from the publication of the Work in *The Deadlands Magazine*, Publisher will hold the exclusive rights to publish the Work in the English language, and that Contributor shall not authorize or permit any third party to publish, reproduce, display or distribute either the Work or any excerpt, portion, version, abridgement, or revision thereof in any medium during the four month exclusivity period; on an individual basis, Publisher will make accommodations for publication of the Work if the Work is chosen for inclusion in "Best of the Year" anthologies, single-author collections, or excerpts on personal author websites.

The right to copy, reproduce, adapt (only as necessary for purposes of technical implementation as contemplated herein), distribute, archive, transmit, display, and maintain the Work on *The Deadlands* website (or any successor or affiliate website) during the four-month exclusivity period and indefinitely thereafter in an archival section, provided, however, that Contributors of fiction Works may request removal of said Work from the website at any time after the expiration of the Exclusivity Period (but not before such date), by giving Publisher thirty days prior written notice. Following receipt of such notice, Publisher shall use commercially reasonable efforts to comply with Contributor's request in a timely fashion.

The non-exclusive, worldwide, royalty-free right to republish the Work or cause the Work to be republished in the annual anthology consisting of material first published in *The Deadlands*, with the contributor receiving one copy of any paperback edition.

Contributor hereby represents and warrants to Publisher that

the Work is original to Contributor and has not been previously published (except for material that is in the public domain or used with permission of its owner);

Contributor has full right and power to make this Agreement and grant the rights granted hereunder;

Contributor has not previously granted to any third party any right or interest in the Work;

the Work will not infringe any copyright, trademark, service mark, privacy or publicity, or any other right, of any person or entity, will not defame any person or contain any obscene material;

Contributor has obtained the right to use any third party material used in the Work and has paid in full any and all fees, royalties, residuals and other charges of any kind required for the full use and exploitation of the Work by Publisher hereunder;

and all persons or entities that performed any services or provided any materials in connection with the Work have authorized all of the rights granted to Publisher hereunder and have been paid in full for such services or materials.

In addition, Contributor represents and warrants that in the production of the Work, all laws, statutes, ordinances and regulations of each country, state, city, or other political entity having jurisdiction were fully complied with, as were all rules, regulations, and requirements of any union or guild having jurisdiction thereof. Contributor shall indemnify and hold harmless Publisher from and against any and all losses, damages, or expenses (including reasonable attorneys' fees) that Publisher may incur as the result of any claim arising from the breach of any representation, warranty or covenant made by Contributor in this Agreement. Contributor agrees to cooperate fully in the defense of any legal action that might arise from creation or publication of any Work.

Publisher reserves the right to make edits to the Work, for grammar, punctuation, style, and usage. Publisher agrees not to make changes to the Work without approval of Contributor. All edits will be confirmed and approved by Contributor before publication. If *The Deadlands* fails to publish the Work within 12 months of the date of this contract, all rights granted revert back to the Contributor. In any such event, Contributor shall retain any payments made under this agreement.
